

MOTHER'S DAY WIN YOUR WISH LIST 2023 GIVEAWAY OFFICIAL RULES

1. HOW TO ENTER:

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED. The Win Your Wishlist Mother's Day Wishlist Giveaway (the "Giveaway") is sponsored by Blain Supply, Inc. ("Sponsor"), 3507 E. Racine St., P.O. Box 5391, Janesville, Wisconsin (the "Giveaway Address").

2. ELIGIBILITY:

Those who are eligible in accordance with these Official Rules will automatically be entered in the Giveaway when completing and saving a Wishlist at <https://www.farmandfleet.com/gift-registry/> (the "Farm & Fleet website") or on the Blain's Farm & Fleet app during the Entry Period (as defined below) (the "Registration"). Entry is open to legal residents of the 48 continental United States and DC (the "Eligible Territory") who are 18 years or older at the time of entry and who are not: (i) employees of Sponsor or (ii) immediate family members or household members of such persons. Participation in any part of the Giveaway constitutes a participant's agreement to be bound by these Official Rules. Participants agree to be bound by the decisions of Sponsor with respect to this Giveaway and such decisions shall be final.

3. HOW TO ENTER:

Between April 24, 2023 and May 14, 2023 (Central Time) (the "Entry Period"), Individuals who complete and save a Wishlist via the Farm & Fleet website or Farm & Fleet app will be automatically entered in the Giveaway. Alternatively, an eligible entrant may enter during the Entry Period by visiting customer service in any Blain's Farm & Fleet store location to enter with no purchase necessary. All entries submitted become the property of the Sponsor and none will be returned. If for any reason the Giveaway is not capable of being conducted as contemplated in the Official Rules, including if due to technical failures which compromise the administration or integrity of the Giveaway, Sponsor, in its sole discretion, reserves the right to terminate or modify the Giveaway. Sponsor reserves the right to disqualify any entrant who tampers or attempts to tamper with the entry procedure or the Giveaway or violates these Official Rules.

4. GIVEAWAY PRIZE; ODDS.

One (1) Prize winner (the "Winner") will receive the following Prize (the "Prize"): a five-hundred-dollar (\$500) gift card to Blain's Farm & Fleet (Approximate Retail Value \$500) (the "Prize"). No transfer or substitution of prize permitted except where required by law. If the Prize, or any portion of such prize, becomes unavailable, the Sponsor may award a substitute prize of equal or greater value. Odds of winning depend on the number of eligible entries received in the Giveaway. Taxes on the Prize are the sole responsibility of the Prize Winner. A tentative Prize winner will be selected in a random drawing to be held on or about May 17, 2023 (the "Drawing"). The selected entry will be the tentative Prize winner, subject to confirmation by Sponsor of compliance with the Official Rules. Sponsor will use reasonable efforts to notify the tentative Prize winner via e-mail and/or telephone within five (5) days of the drawing and at that time Sponsor may, at its election, require a tentative Prize winner to complete Sponsor's Affidavit of Eligibility and Liability and Publicity Release (the "Release") as a condition to receiving the Prize.
