

# Blain's Farm & Fleet – Official Sweepstakes Rules

70<sup>th</sup> Anniversary Events

**1. NO PURCHASE NECESSARY TO ENTER OR WIN THE 70<sup>TH</sup> ANNIVERSARY EVENTS (THE "SWEEPSTAKES"). A purchase will not improve your chances of winning.** Open only to legal residents of, and residing in, the contiguous 48 United States, the District of Columbia who are 18 years or older as of 04/25/2025. Void in Alaska, Hawaii and where restricted or prohibited by law. Sweepstakes begins 04/25/2025, at 8:00 A.M. Central Standard Time ("CST") and ends 05/31/2025, at 7:59 P.M. CST ("Sweepstakes Period"). The Sweepstakes is sponsored by Blain's Farm & Fleet ("Sponsor"). By entering the Sweepstakes, you accept and agree to be bound by these Official Sweepstakes Rules.

**2. ELIGIBILITY:** Employees of Sponsor, their respective parents, subsidiaries, and affiliated companies, divisions, suppliers and advertising and promotion agencies, and the immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and household members, whether or not related, of each such employee are not eligible to enter or to win the Sweepstakes. The parties acknowledge that the Sponsor shall not be liable for the reimbursement of any prizes or other amounts payable to entrants who are in violation of these eligibility requirements or these Official Sweepstakes Rules.

### **3. HOW TO ENTER:**

During the Sweepstakes Period, there are two (2) ways to enter the Sweepstakes:

**(A)** Rewards Members can enter the Sweepstakes through downloading the Blain's Farm & Fleet app on their smartphone and can scan QR codes throughout the stores to enter into each contest.

**(B)** See the customer service desk at your local Farm & Fleet store to fill out an entry form, limit 1 entry per customer per entry period. No purchase necessary.

Limit one entry per person regardless of means of entry. All entries submitted become the property of the Sponsor and none will be returned. If for any reason the Sweepstakes is not capable of being conducted as contemplated in the Official Rules, including if due to technical failures which compromise the administration or integrity of the Sweepstakes, Sponsor, in its sole discretion, reserves the right to terminate or modify the Sweepstakes. Sponsor reserves the right to disqualify any entrant who tampers or attempts to tamper with the entry procedure or the Sweepstakes or violates these Official Rules.

#### **6. WINNER SELECTION AND NOTIFICATION:**

Tentative Prize winners will be selected in a random drawing to be held on or about June 1, 2025 (the "Drawing"). The selected entry will be the tentative Prize winner, subject to confirmation by Sponsor of compliance with the Official Rules. Sponsor will use reasonable efforts to notify the tentative Prize winner via e- mail and/or telephone within five (5) days of the drawing and at that time Sponsor may, at its election, require a tentative Prize winner to complete Sponsor's Affidavit of Eligibility and Liability and Publicity Release (the "Release") as a condition to receiving the Prize. The notified person, at his or her discretion, may disclaim the Prize by not claiming such Prize or by not completing and returning to Sponsor the Release within five (5) days and in such case an alternate tentative Prize winner will be selected.
